- Students who have had OSS or ISS must complete community service hours and it be verified in order to regain eligibility.
- Students that have been charged with a felony, drug or alcohol offense are not eligible to attend.
- Students attending from another school must meet the same requirements as DHS students and be approved by the DHS SRO.
- Follow BCPS Code of Conduct during the event.
